This document has been developed in line with the ACT [Public Health \(Restricted Activities – Gatherings, Business or Undertakings\) Emergency Direction 2021 \(No. 2\)](#) based on [these guidelines](#).

A hard copy of this document is to be kept in the church office to be produced if requested by compliance and enforcement officers.

RELEVANT REGULATIONS & ADVICE

- Current ACT Government [regulations](#), [advice](#) and [directives](#) (updated 12 November 2021).
- [Returning to worship](#) advice from the LCA NSW/ACT District
- Current ACT Government regulations allow religious ceremonies to take place with up to 25 people, or one person per four square metres, whichever is less, so long as the Check In CBR app is used. Currently we can accommodate up to 25 people in the worship centre, 20 people in the hall and 4 people in the meeting room. 'Workers' – which includes people conducting a worship service (worship leaders, musicians, tech volunteers and welcomers/ushers) – do not count towards this limit.
- [Good hygiene](#) and [physical distancing](#) must be practised.
- Current ACT Government advice includes:
 - Masks mandatory during worship indoors
 - Manage the flow of people to promote physical distancing, particularly where people enter and leave the place of worship.
 - Encourage physical distancing of 1.5 metres between each group or household.
 - Avoid using collection plates and other shared equipment during services.
 - Limit the use of books, if possible.
 - Singing carries a high risk of transmission of COVID, due to increased droplet spread. While singing is currently permitted in the ACT, venues and event organisers should take steps to minimise the risks associated with this activity.
 - Choirs and performers should maintain a minimum of two metres from each other and from the audience/ congregation.
 - Congregational singing is discouraged. However, if congregations wish to allow singing they need to include this in their COVID Safety Plan and ensure that members maintain a minimum of 1.5 metres from each other whilst singing.
- There are no government restrictions on the distribution of Holy Communion in the ACT.
- From the 12th November, 40 people will be able to gather in the Hall & 8 people in the Meeting Room
- From the 12th November, 80 people will be able to gather in the Church

CURRENT STATUS

- In-person Sunday morning worship has resumed in accordance with the risk assessment and controls listed below.

- Face masks are mandatory during worship in the church building and encouraged at other times and in other spaces
- The office is staffed and open during regular hours, and people may visit in person.
- The meeting room and hall are available for use by church groups in accordance with the risk assessment and controls listed below.
- External groups are able to hire the church and hall spaces, subject to the risk assessment and controls listed below.
